# MINUTES OF THE MEETING HELD ON WEDNESDAY 21<sup>ST</sup> FEBRARY 2018

15/2018 Public Question Time: James Stubbs gave an update on the renovation of the old milestone and was thanked for undertaking the work.

16/2018 The Minutes of the meeting of 24<sup>th</sup> January 2018 were accepted as a true record.

17/2018 There was no police report presented.

18/2018 County Council Report: Cllr. Wilkinson

- (1) A meeting had been held about the parking and rubbish around Coneygarth and parking on Roughley Bank. Monitoring was ongoing. Cllr. Barningham would speak to the district council about rubbish collection
- (2) Signage to the A1 was being addressed
- (3) The zebra crossing at Leeming Bar has been completed
- (4) The footpath before the crossing in Aiskew had been cleared. The Chair reported that only part of the problem had been addressed. The Parish Portal should be used to report ACTION Cllr. Asquith

19/2018 District Council Report: Cllr. Barningham that the MAD Grant scheme was reopening and Parish Councils would be eligible to apply

20/2018 Leeming Bar Residents Association report was circulated. A meeting is to be held about Tour De Yorkshire preparations in Leeming Bar

21/2018 Highways.

(1) An email has been received from a new resident in Aiskew asking for weight restrictions because of the large amount of HGV's and buses travelling through the village. A traffic survey is being carried out by

- NYCC, the matter will be considered when the results are given to the Parish Council.
- (2) The Chair queried the criteria for bus shelters being provided and litter bins placed at bus stops ACTION: Cllr. Asquith
- (3) Leaf mould was growing on the footpath between the railway and the stile towards Aiskew Mill making it slippy ACTION: Cllr. Asquith will report on Parish Portal
- (4) It would appear that people are drinking and taking drugs behind Kingfisher Play Park. ACTION: Cllr. Asquith report to police.

23/2018 **Play Areas**: It was agreed to extend Farm & land Services Contract for another two years and the increase in costs was approved. ACTION: Cllr. Asquith will request a grass cutting schedule from contractors.
