b. **PROPOSAL:** Erection of new warehouse units to serve an existing car accessories business

LOCATION: Land between 39 & 41 Northallerton Road, Leeming Bar.

APPLICANT: Chris Watson - **ZB24/02311/FUL.** – This was sent to Councillors via Email (24 January 2025). The majority **Objected** to this application, with the following reasons given.

- 1. The owner of the 4x4 Parts Business already has a substantial industrial complex in Meridian Park in the Leeming Bar industrial area. There is a concern that moving some of his operation to this proposed site will begin to industrialise a residential area of Leeming Bar.
- 2. The Parish Council is concerned about an increase in larger traffic through Leeming Bar. The most direct and quickest route from the current factory to the proposed warehouse, will breach the 7.5 tonne weight limit in Leeming Bar as drivers take the easier option through the centre of Leeming Bar via the roundabout missing out the bypass and going the long way round.
- 3. There are currently 3-4 plots of land for sale in and around his current factory location, the Parish Council feel these plots would be a much more suitable location for warehousing to support his current operation.
